U.S. Environmental Protection Agency was asked by the Genessee County Land Bank Authority to assist in removal of the former Brown's Funeral Home structure, left behind after a series of fires destroyed the building. A previous site survey identified asbestos within what has now become the building ruins.

EPA is planning to conduct cleanup and disposal of the contaminated ruins and debris at the property. Work will consist of:

- Demolishing the building ruins to remove asbestos-containing materials.

- Transporting and disposing of the contaminated waste at an approved facility.
- Following a safety plan, including air monitoring, to protect the health of workers and the public.
- Following COVID-19 safety protocols as outlined in a safety plan.



Upcoming Work in Your Neighborhood

Beginning in April, EPA will be starting work to remove asbestos-containing material and contaminated debris from the former Brown Funeral Home.

Work is expected to take place Monday through Friday, 7 a.m. to 5:30 p.m. and last up to three months.

EPA and its workers will follow a safety plan that includes air sampling and monitoring to make sure workers and the nearby residents remain safe during the cleanup.
